KDHE HAI/AR Section Updates:

- Influenza recommendations have been updated to align with CDC recommendations.
- KDHE recommendations on home isolation are as follows (updated 5/22/24):
- Influenza Control of Cases
 - For each person hospitalized with a case, droplet precautions shall be followed for seven days following onset of illness or for the duration of the illness if the case is in an immune-compromised patient.
 - For each person with a case shall remain in home isolation for seven days following onset of illness or for the duration of illness if the case is immune compromised, except when seeking medical care.

NHSN Tips:

- Influenza Annual Survey data collection begins October 1.
 - Define your process for tracking employees, independent practitioners, students, volunteers, trainees, and other contract staff's vaccination status prior to October 1.
 - You may enter data into NHSN weekly, monthly or wait until the conclusion of defined data collect period (10/1/24-3/31/25), but keep in mind with each update you will need enter totals into the sheet, as it will not add to previous entered data, it replaces what was previously entered.
