- Modifications to the Long-term Care Facility Component (email received 10/18/2024 from the NHSN team)
 - Reporting Week Clarification: data can be reported for the current or prior week in NHSN by Sunday of the current week. For example, facilities can report data for week-ending 10/6/24 or for week-ending 10/13/24 by 10/13/24. Any day of the week is fine to report, as long as you report once a week. For questions about CMS compliance, please contact: DNH Enforcement@cms.hhs.gov.
 - Resources: the <u>LTCF | Respiratory Pathogens and Vaccination Module | NHSN | CDC</u> webpage has resources including revised forms, instructions, FAQs, .CSV file templates, and file layout documents. Please see the <u>RPV Module Resident Summary Guidance Document</u> to assist with entering data into the new module.
 - O Analysis and Reporting RPV Resident To view data corresponding to the RPV Summary form, navigate to Analysis > Generate datasets > Generate reporting datasets. Once datasets have been generated, select Analysis from the home page and then select reports. On the Analysis Reports screen, click the Respiratory Pathogens and Vaccination folder, then click the RPV Summary sub-folder. Next, right-click on "Line Listing Respiratory Pathogens and Vaccination Resident" and click Run Report. To view Resident data for dates before 9/30/24, navigate to the reports in the Archived folder.
- Technical issues in the application for LTCF Respiratory Pathogens, Vaccination, and Point of Care Modules (email received 10/15/2024)
 - **RPV Module**: The COVID-19 Vaccination HCP tab is not currently visible from the menu when you hover over Respiratory Pathogens and Vaccination on the home page. This form was not removed, and there are no changes in reporting requirements. You can still access this form by clicking RPV Summary and selecting the reporting week from the calendar view.
 - Analysis and Reporting HCP: To view HCP COVID-19 Vaccination data, please
 utilize the report titled "Line Listing All COVID-19 Vaccination Cumulative
 Summary Data HCP" under Respiratory Pathogens and Vaccination > Archived >
 COVID-19 Vaccination. Currently, the version of this report in the RPV Summary
 folder is not working appropriately, however the line list mentioned above in the
 Archived folder will populate the HCP data appropriately.
 - Archived: COVID-19/Respiratory Pathogens Surveillance Pathways Module: Issue preventing users from adding and/or editing data for dates prior to 9/30/24. The issue is occurring for both facility and group users. We will inform users when this function has been restored.
 - **Point of Care Module:** Manual entry is requiring gender identity even though this question is not indicated as a required field
